Dear Applicant:

The Twenty-Nine Palms Gaming Commission is an arm of Tribal Government established pursuant to federal law to ensure the integrity of the Spotlight 29 Casino gaming operations. It is a separate legal entity from Spotlight 29 Casino. Because of its status under federal law and recognized concepts of sovereign immunity, the Gaming Commission is not covered by California and federal labor relations and employment laws. To the extent the Commission voluntarily complies with such laws it is not waiving its immune status.

In order to continue processing your employment application, you need to understand that, aside from passing a written test and the qualifying interviews, **you must be able to qualify for a gaming license**. Our Background and Investigations Department will conduct an investigation into your character, reputation for honesty, credit worthiness, habits, ability, criminal records, if any, education, residency and employment history. Persons who know you, now or in the past may be contacted and questioned about you.

The Twenty-Nine Palms Gaming Commission will hold any information obtained by the Commission from any source confidential from all persons, except as required by law.

The Background Investigators are government employees of the Sovereign Nation of the Twenty-Nine Palms Band of Mission Indians and reserve the right to request additional information as needed or deemed appropriate in compliance with the Federal, State or Tribal laws and ordinances.

In signing your application for employment, you agree to comply with the requests and inquiries made by the Background and Investigations Department. Not qualifying for a Gaming License is not a reflection of your employment qualifications, but it may preclude you from being employed by the Gaming Commission.
